Subject: PUBLIC CORRUPTION

OUR NIGHTMARE BEGINS ON 11/4/06 WHEN MY DAUGHTER (CHAUNELL ROBERSON) HAD A STROKE IN THE PEDIATRIC INTENSIVE CARE UNIT AT BANNER DESERT MEDICAL CENTER. THE HOSPITAL AT THE TIME HAD NO NEUROSURGICAL TEAMS ON STAFF. THE HOSPITAL THEN BEGAN COMMITTING HEALTH CARE FRAUD STATING ALL MRI/ CT SCANS WERE NORMAL. MY DAUGHTER WAS IN A COMA. ON 11/26/06 CHAUNELL WAS TRANSFERRED TO BARROW NEUROLOGICAL INSTITUTE. BARROW NEUROLOGICAL INSTITUTE CONTINUED TO STATE ALL MRI/ CT SCANS OF CHAUNELL'S BRAIN WERE NORMAL. CHAUNELL WAS IN 2 COMAS AND HAD MULTIPLE RESPIRATORY ARRESTS. CHAUNELL WAS DISCHARGED ON 2/27/07 FROM BARROW NEUROLOGICAL INSTITUTE. AGAIN ALL DOCTORS CONTINUED TO STATE THAT CHAUNELL'S MRI AND CT SCANS OF HER BRAIN WERE NORMAL.

ON 6/20/07 CHAUNELL ROBERSON HAD A MRI SCAN DONE AS AN OUTPATIENT AT BARROW NEUROLOGICAL INSTITUTE. RIGHT AFTER THE MRI SCAN WAS DONE I ASKED FOR A COPY OF IT. THEY GAVE ME A COPY BEFORE THE NEURORADIOLOGIST "READ" IT. I CALL THIS MY "RAW MRI". THE MRI SCAN OF THE BRAIN WAS THEN READ AS NORMAL AND DID NOT MATCH THE "RAW MRI" SCAN THAT I HAVE. I TOOK THE "RAW MRI" SCAN TO UPPER MANAGEMENT AT BARROW NEUROLOGICAL INSTITUTE ON 7/14/08. THEY WANTED TO KNOW WHERE I GOT IT FROM. I TOLD THEM THAT I NEED TO KNOW WHAT THEY KNOW ABOUT MY DAUGHTER SO THAT I CAN MAKE THE PROPER MEDICAL DECISIONS FOR HER. I TOLD THEM I WAS GOING TO TAKE MY DAUGHTER OUT OF STATE FOR A SECOND OPINION.

THE NEUROSURGEON SIGNED OFF ON THE CASE AND MADE A CALL TO AZ CPS AND HAD CHAUNELL TRANSFERRED TO BANNER DESERT MEDICAL CENTER ON 8/22/08. A NEW NEUROSURGEON AND 4 OTHER DOCTORS FROM BANNER DESERT THEN CALLED AZ CPS ON ME AND 1 DAY AFTER CHAUNELL HAD A SHUNT PUT IN HER BRAIN SHE WAS TAKEN FROM THE HOSPITAL PEDIATRIC INTENSIVE CARE UNIT AT BANNER DESERT HOSPITAL ON 9/3/08 BY AZ CPS. THE ALLEGATIONS WERE MUNCHAUSEN BY PROXY AT FIRST AND THEN MEDICAL NEGLIGENCE. I CONTESTED THE DEPENDENCY AND PASSED ALL BONDING ASSESSMENTS, PSYCHOLOGICAL TESTING AND HAIR FOLLICLE DRUG TESTING AND WE WENT TO TRAILS ON 2/4/09. ALL SPEECH THERAPY, PHYSICAL THERAPY, SPECIALISTS (DOCTORS) CHAUNELL WAS GOING TO IN MY CARE WAS STOPPED. DURING THE "CONTESTED DEPENDENCY TRIAL" I TOLD THE JUDGE ABOUT THE "RAW MRI" AND WHY I WAS FALSELY ACCUSED. THE ATTORNEY GENERALS OFFICE REQUESTED THE MEDICAL RECORDS FROM "BACTUS" WHO STORES BARROW NEUROLOGICAL INSTITUTES MRI SCAN AND I RECEIVED COPIES OF THEM FROM THE ATTORNEY GENERALS THEY SHOW EVEN MORE HEATH CARE FRAUD THAT WAS COMMITTED.

ON 3/24/09 IN AZ CPS CUSTODY CHAUNELL WAS ADMITTED TO BANNER DESERT MEDICAL CENTER WITH BACTERIAL MENINGITIS WHERE SHE REMAINED IN THE SAME PEDIATRIC INTENSIVE CARE UNIT WITH THE SAME DOCTOR WHO MADE THE "FALSE ALLEGATIONS" ABOUT ME ON 9/3/08. CHAUNELL REMAINED IN THE PEDIATRIC INTENSIVE CARE UNIT FROM 3/24/09 TO 4/29/09. THE NEUROSURGEON TOOK THE STAND IN THE TRAIL. THE JUDGE FAVORED WITH THE STATE OF AZ STATING I MADE MY DAUGHTER A "DNR" (DO NOT

RESUSCITATE) AND I WAS IN MEDICAL NEGLIGENCE. DR. ROBERT ROSENBERG (MEDICAL DIRECTOR OF THE PEDIATRIC INTENSIVE CARE UNIT AT BARROW NEUROLOGICAL INSTITUTE) WROTE THE ORDER AND THE JUDGE HAD THE MEDICAL RECORDS THAT SHOWED THIS.

I CONTINUED TO DO EVERYTHING AZ CPS DIRECTED ME TO DO IN ORDER TO GET MY DAUGHTER BACK WITH ME.

ON 7/19/09 WE FILED A "NOTICE OF CLAIM" AGAINST AZ CPS.

I HAVE SENT ALL DOCUMENTS SHOWING HEALTH CARE FRAUD AND MY INNOCENTS TO THE DEPARTMENT OF JUSTICE -OFFICE OF INSPECTOR GENERAL. I CALLED THE HHS HOTLINE REPORTING THE FRAUD.

THERE IS A HEALTH AND HUMAN SERVICES- OFFICE OF CIVIL RIGHTS INVESTIGATION WHICH IS ONGOING.

I SENT ALL EVIDENCE TO ATTORNEY GENERAL ERIC HOLDER IN WASHINGTON D.C., I HAVE SENT ALL EVIDENCE TO PRESIDENT OBAMA. I HAVE SENT ALL EVIDENCE TO THE DEPARTMENT OF JUSTICE - OFFICE OF CIVIL RIGHTS COORDINATION AND REVIEW WHO SENT THEM UP TO GEORGINA VERDUGO DIRECTOR OF HEALTH AND HUMAN SERVICE.

I HAVE BEEN IN CONTACT WITH THE NAACP REVEREND TILLMAN.

AZ CPS TOLD MY DAUGHTER IF SHE WAS HAVING ANY MEDICAL ISSUES TO LET THEM KNOW BEFORE SHE CAME HOME OR IF THEY RETURNED CHAUNELL TO ME AND SHE BEGAN TO HAVE HEALTH PROBLEMS THEY WOULD PULL HER BACK OUT OF MY HOME.

THE REUNIFICATION TEAM WAS IN PLACE AND THE CPC(CHANGE OF PHYSICAL) CUSTODY WAS SIGNED BY JUDGE DAWN BERGIN ON 11/23/09.

CHAUNELL CAME FOR HER UNSUPERVISED VISITATION ON 11/24/09. THE REUNIFICATION TEAM WAS HERE AND CHAUNELL NOTIFIED ME THAT THE DAY BEFORE WHEN SHE WAS AT SCHOOL IN AZ CPS CUSTODY. SHE BENT DOWN IN THE BATHROOM TO PICK UP HER SCHOOL BOOKS THAT WERE ON THE FLOOR AND WHEN SHE CAME UP SHE HIT THE SHUNT ON HER HEAD ON THE HOOK WHERE YOU HANG YOUR PURSE. CHAUNELL STATES IN FRONT OF ME AND VENUS FROM THE REUNIFICATION TEAM THAT THE SHUNT IN HER HEAD FELT LOOSE. I EXPLAINED TO CHAUNELL THAT I WAS SCHEDULED TO TAKE HER FOR THANKSGIVING FROM 11/25/09 TO 11/29/09 AND THAT IF THERE IS SOMETHING WRONG WITH THE SHUNT THEN IT NEEDS TO BE ADDRESSED BEFORE CHAUNELL COMES HOME FOR THANKSGIVING WEEK-END. THE REUNIFICATION TEAM TOLD ME TO NOTIFY THE FOSTER MOM AND CPS ABOUT WHAT CHAUNELL WAS SAYING.

I CALLED THE FOSTER MOM AND SHE CALLED THE NEUROSURGEON WHO STATED HE WANTED CHAUNELL TO COME INTO BANNER DESERT ER. THE FOSTER MOM TOOK CHAUNELL TO ER AND I MEET THEM THERE.

THEY DID A CT SCAN OF CHAUNELL'S BRAIN AND STATED THAT SHE HAS AIR AROUND THE SHUNT.

THEY ADMITTED CHAUNELL TO THE PEDIATRIC INTENSIVE CARE UNIT AND THE NEXT MORNING THE SAME NEUROSURGEON THAT WROTE FALSE ALLEGATIONS ABOUT ME ON 9/3/08 STATED THAT SOMEONE "INJECTED THE SHUNT WITH AIR"

THIS STARTED A WHOLE NEW INVESTIGATION BY AZ CPS . MY CASE WORKER TAMMY HAMILTON – MACALPINE WHO IS ALSO LISTED IN THE PENDING LAWSUIT NOTIFIED ME ON 11/25/09 FROM BANNER DESERT PICU BY TELEPHONE THAT I WILL NOT BE TAKING CHAUNELL HOME FOR THE HOLIDAY WEEK-END AND THAT HER AND HER SUPERVISOR BONNIE BROWN (ALSO LISTED IN THE PENDING LAWSUIT) WOULD BE COMING TO MY HOME ON 11/30/09 AT 10AM TO DISCUSS THE “NEW ALLEGATIONS” TAMMY WOULD NOT TELL ME THE ALLEGATIONS AGAINST ME.

ON 11/30/09 AT 9:40 AM TAMMY HAMILTON-MACALPINE CALLED ME AT HOME AND STATED THAT I CAN HAVE NO CONTACT WITH CHAUNELL BY TELEPHONE OR E-MAIL. THAT THE CHANGE OF PHYSICAL CUSTODY HAS BEEN PULLED ALONG WITH THE REUNIFICATION TEAM AND THAT THE UNSUPERVISED VISITATION HAS BEEN PULLED. AGAIN I ASKED TAMMY HAMILTON-MACALPINE WHAT THE "ALLEGATIONS" ARE AND SHE SAID SHE CANNOT FIND THE "PIECE OF PAPER".

I HAVE DOCUMENTS TO SUPPORT THIS PUBLIC CORRUPTION THAT HAS TAKEN PLACE. I WENT TO THE PHOENIX FBI ON 11/27/09 AND SHOWED THEM ALL OF MY DOCUMENTS WHICH THEY TOOK AND SAID THEY WOULD INVESTIGATE BUT IN THE MEAN TIME THE ONLY THING I CAN DO IS CONTACT YOU AND OTHER POLITICAL LEADERS AND STAY IN CONTACT WITH THE NAACP REVEREND TILLMAN.

I HAVE DONE NONE OF THE ALLEGATIONS AGAINST ME. I HAVE BEEN FALSELY ACCUSED ONLY BECAUSE I DISCOVERED THIS HEALTH CARE FRAUD AND REPORTED IT.

THIS CASE SHOULD HAVE NEVER WASTED ALL OF THE TAX PAYERS MONEY LIKE THIS. AS YOU KNOW THE AZ BUDGET IS HURTING AND AZ CPS IS WASTING MONEY INVESTIGATING ME WHEN THE ONLY REASON THE DOCTORS ARE SAYING THIS IS BECAUSE I DISCOVERED THAT THEY WERE SUMMITTING FRAUDULENT CLAIMS TO MEDI-CAD.

CHAUNELL IS ON MERCY CARE LONG TERM DISABILITY THRU SSI.

SHE IS DISABLED AND DENIED MEDICAL CARE AND HER CIVIL RIGHTS HAVE BEEN VIOLATED.

NO ONE FIGHTS THIS HARD IF THEY HAVE DONE SOMETHING WRONG. THE DOCTORS AND HOSPITALS HAD NO RIGHT TO LEAVE MY AFRICAN-AMERICAN DAUGHTER’S BRAIN BLEEDING WITHOUT TREATMENT BECAUSE THEY MADE A MISTAKE AND NOW THEY ARE TRYING TO BLAME ME FOR EXPOSING THIS INJUSTICE.

I WOULD LIKE TO MEET WITH YOU AND SHOW YOU MY EVIDENCE.
